Incase the institution could not commence the above mentioned courses for what ever reasons during the two years period from the date of issue of the letter, the approval becomes invalid and the applicant society/Trust shall have to make fresh application to the concerned State Government for grant of fresh approval.

The approval is further subject to fulfillment of following conditions.

- That the management shall provide adequate funds for development of land and for providing required infrastructural, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
